This international summer institute focuses on the important global issue of designing and implementing effective sexual and gender-based violence prevention interventions in public education, exploring especially international and comparative perspectives that are much needed in this research field. The institute is designed for scholars, students, educators, community activists, and practitioners interested in developing international and comparative skills in collecting and interpreting data related to gender-based and sexual violence prevention, as well as planning and evaluating violence prevention strategies in higher education and beyond.

The institute will focus on violence prevention in multicultural and multiethnic societies, drawing from intersectional, postsocialist, postcolonial, and social justice theories where sexual and gender-based violence prevention is understood in relation to structural, cultural, social, and behavioural factors. These factors produce and reinforce what are considered to be root causes of sexual violence locally and globally: patriarchy, socialist and capitalist economies, racial, ethnic, and gender and sexual identity formations, as well as educational, media and state institutions supporting inequalities that produce forms of violence in education and beyond. The institute program is organized by topical sessions facilitated by an international team of Canadian and Croatian scholars specializing in gender and sexuality studies, philosophy, research design and grant applications focused on gender/women, educational curriculum, and race, gender, and ethnic relations in Europe and North America. Special panels feature student research and analysis of intertwined forms of sexual, gender, racial, (post)colonial, political and cultural violence showcasing the interests and work of an emerging scholars in the field. The panels feature student research based in Russia, India, Croatia, Canada, China, the United States and other locales mapping the global manifestations of violence yet dedicated efforts of educators, counsellors, activists and policymakers to stop such violence and support equity and social justice locally and globally.

**FACULTY, Ontario Institute for Studies in Education, University of Toronto, CANADA**

**Dr. Hayley Brooks**, Social Justice Education, OISE, University of Toronto specializes in the areas of critical international education, media and cultural literacy, and gender-based violence prevention in public education. She has delivered guest lectures, workshops, and scholarly presentations to academic and community audiences including K-12 educators in Ontario, international exchange students in higher education, international scholars and activists in violence prevention, and colleagues at the Canadian Society for Studies in Education, the American Educational Research Association, and the Association for Women and Gender Studies/Recherches Féministes. Her research on the relationship between mass media, popular culture, and sexual and gender-based violence prevention is published in the *Journal of Media Literacy Education* (2019) and *Comparative and International Education* (2022). Her innovative study of curriculum designs for international education and violence prevention is forthcoming in the *Annual Review of Comparative and International Education*. In 2022, Ms. Brooks received the University of Toronto's Graduate Award for Scholarly Achievement in the Area of Gender-Based Violence for her research, service, and commitments to violence prevention in and through education.



**Dr. Hubert Brard** earned his Doctorate Degree in Education at the Ontario Institute for Studies of Education, University of Toronto in 2019. He is currently an administrator at York Region District School Board who served previously as the Instructional Coordinator for Health Education at the Peel District School Board (2012-2018). In these roles, he has led the development and implementation of the sex and sexuality education curriculum in public K12 education in Ontario, Canada. He has taught academic courses as Adjunct and Assistant Professor for Queen's University and Brock University, Canada. Dr. Brard studies power relations in educational organizations that implicitly marginalize students and youth who do not fit dominant social sexual and patriarchal norms. He has published scholarly articles, study guides, chapters and e-modules with the Ontario Principal Council, Good Day Press, and Breakwater Books. His current projects include two book chapters entitled *From Diverse to Equitable School Leadership* and *An Invitation to Queering Principal Leadership* that use an auto-ethnographic approach to explore leadership and sexuality in public education.



**Ms. Lara Cartmale**, M.A., M.B.A., is the Director, Research and International Initiatives, Ontario Institute for Studies in Education (OISE), University of Toronto (UofT). With over 25 years experience working in education administration, she is a specialist in supporting faculty and graduate student research projects and grant applications competing for national and international funding awards. Ms. Cartmale has been recognized by the Society of Research Administrators International, as well as the Canadian Association of Research Administrators, and the University of Toronto for excellence in research administration. She is an invited member of the advisory board of the Centre for Research and Innovation Support and leads the Canadian chapter of a special interest group in higher education research administration.



**Dr. Miglena S. Todorova** is Associate Professor and Associate Chair of Social Justice Education Department, Ontario Institute for Studies in Education, University of Toronto, Canada. Her interdisciplinary research, teaching and publications cross and relate sexual and gender-based violence, transnational feminisms, critical race studies, and educational research in Canada, the United States and former socialist countries in Eastern Europe and the Balkans. Dr. Todorova is the Director of the Centre for Media, Culture and Education at the Ontario Institute for Studies in Education where her research further supports media and cultural literacy education in relation to sexual violence prevention locally and globally. Todorova's work has been published in leading academic journals, such as *Meridians: Race and Transnational Feminisms*, *TOPIA: Cultural Studies*, *Canadian Woman Studies*, *Comparative and International Education*, and *Interventions: International Journal of Postcolonial Studies*. She is the author of *Unequal under Socialism: Race, Women and Transnationalism in Bulgaria* published in 2021 by the University of Toronto Press. She is the co-editor of *Decolonizing the Spirit in Education and Beyond: Resistance and Solidarity*, 2019 by Springer Publishing. Todorova is the recipient of the 2023 CSWE Award for Outstanding Research and Teaching Contributions to Women in Canada.



**Professor Njoki Wane** is a distinguished scholar and educator in the areas of Black Feminisms, African Indigenous knowledges and spirituality, African and African Canadian women's teaching and learning, anti-racism education and Anti-Black Racism. Prof. Wane is also the Chair of the Social Justice Education Department, Ontario Institute for Studies in Education, University of Toronto. She has published 4 books, 18 edited volumes, and dozens of book chapters and refereed journal articles. She has presented her work at over 300 conferences locally and internationally, often as a keynote speaker. From 2011 to 2014, Professor Wane served as the University of Toronto's Special Advisor on Status of Women Issues. From 2018 to 2021, she also served as Special Advisor to Vice - President; Human Resources and Equity, contributing to research and policy development concerning the intersectionality of gender with race, disability, sexual orientation and aboriginal status, and the impact of these issues on the lived experiences of women faculty, staff and students. She also served as Director, Center for Integrative Anti-Racism Studies (CIARS) at OISE from 2006 to 2014. She is currently serving as Co-Director for the Center for Black Studies in Education at OISE.

### FACULTY, University of Rijeka, CROATIA



**Snježana Prijić Samaržija, Ph.D., Rector of the University of Rijeka** is a full-time professor at the Faculty of Humanities and Social Sciences at the University of Rijeka. The main areas of her scientific interest are social philosophy, epistemology, and applied ethics. She is the founder and first director of the University of Rijeka Foundation. She has founded the Centre for Advanced Studies South East Europe, which she also directs. Before her two rector's mandates, she spent eight years as the vice-rector for students and studies. Throughout fifteen years of active participation in university management, she has assumed the role of an expert in numerous national and international committees and advisory boards in the domain of universities' policies and practices. She is president of YERUN (Young European Research University Network), a member of the Steering Committee for Education (and Steering Committee Bureau) at the Council of Europe and a member of YUFE Strategy Board (European University Alliance 'Young Universities for Future of Europe').


**Sanja Bojanić, Associate Professor, Center for Advanced Studies UNIRI**, is a researcher immersed in philosophy of culture with an overarching commitment to comprehend contemporary forms of gender, racial and class practices, which underpin social and affective inequalities specifically increased in the current societal and political contexts.



She expanded and tailored her interests at the University of Paris 8 where she obtained an M.A. in Hypermedia Studies at the Department of Science and Technology of Information and an M.A. and Ph.D. at Centre d'Etudes féminines et d'étude de genre. This process ultimately led to interdisciplinary research based on experimental artistic practices, queer studies, and particularities of Affect Theory. Her research and scientific work are fostered through various projects. Author and Editor of several books and manuals, she published over forty peer-reviewed papers on topics related to her field of expertise, such as "Feminist responses to populist politics", „The Vocabulary of Distance“, "On the Eternal Present", and "Retorica dell'emancipazione vs. retorica della misoginia“.



**Dalida Rittossa, Associate Professor at University of Rijeka, Faculty of Law**, is an professor at the Department of Criminal Law, Faculty of Law in Rijeka. She is the author of a number of scientific papers and two books in the field of criminal law, criminology, victimology and human rights. As a hearty advocate of vulnerable groups' rights, Ms. Rittossa has recently focused her research on issues concerning criminal legal protection of children, sexual crimes against children, family violence and rights of people with mental difficulties. She is a principal investigator of the Croatian Science Foundation project IP-CORONA-04-2086 "Life in the Time of COVID-19 - Social Implications on the Security and Well-Being of Vulnerable Groups in the European Context". In an effort to bring scientific conclusions closer to both the professional and the general public, she regularly presents the results of her research at international and domestic scientific conferences. Truly supporting the idea that community should be informed about the correct implementation of legal norms, she is a cofounder of the "Law in Community", a lifelong learning program.



**Ms. Lorena Zec, Psychologist and Coordinator of Development Programmes, SOS Rijeka** - center for nonviolence and human rights, Croatia, is a feminist psychologist and is active in the field of human and women's rights, both professionally and as an activist. Since 2014, she has been co-leading the NGO SOS Rijeka - centre for non-violence and human rights, where she runs the Counselling Centre for victims of domestic, partner and sexual abuse and works directly with women who have experienced gender-based violence. In addition to direct work with victims of violence, she is also active in advocacy, is the author of many reports and analyses in the field of gender equality and protection of victims of violence. For several years, she

has been an active co-organizer of protests and public actions related to the protection of human rights and awareness campaigns related to women's rights and gender-based violence. She is an experienced educator and has been participating for a long time in the organization and implementation of various educations about GBV for experts from different fields of work.

### Arriving in Rijeka by plane

Rijeka has its own airport – [Rijeka International Airport](#). However, it is a small airport with only a few flights to different European cities. All participants are asked to check themselves if any available flights could suit them. If you can fly to Rijeka, a bus shuttle service can then transfer you to Rijeka (tickets can be bought on the bus or online at the following [link](#)).

An equally good option to travel to Rijeka by plane is to fly to "**Franjo Tuđman**" International Airport Zagreb and then transfer to Rijeka by bus. Bus options from Zagreb are mentioned below.

### Direct bus line from Zagreb Airport to Rijeka

The best option to travel to Rijeka is to take the bus straight from the airport. However, there is only one bus per day, so you should try and arrange your flights with the bus time in mind. The second option is mentioned below this section.

**From "Franjo Tuđman" International Airport Zagreb to Rijeka:** 170 km, approximately 2 hours and 15 minutes.

→ Croatia Airlines shuttle bus from Zagreb: every day at **3.30 PM**

→ Croatia Airlines shuttle bus from Rijeka (leaves from Jelačićev trg): every day at **5.00 AM**

**One-way ticket costs 19,89 €. Return ticket costs 33,15 €.**

### Bus to Rijeka via Zagreb Bus Station

If you cannot make it to the bus at 3.30 PM from Zagreb Airport, the second option is to transfer from Zagreb airport to the **Zagreb central bus station** ([address](#): Avenija Marina Držića 4, HR-10000 Zagreb) and to take an intercity bus to Rijeka.

We recommend that you use the Flixbus service, which has buses to Rijeka at 11.30 AM, 3.00 PM and 7.30 PM on Mondays. Detailed information about the timetable and ticket purchases can be found on the [FlixBus webpage](#).

Finally, if none of the above options suit you, one more bus company (Croatia Bus) provides travel to Rijeka from the Zagreb bus station from 5.30 AM until 10.30 PM – please see the timetable here: <https://www.akz.hr/purchase-tickets-98/instructions-for-ticket-purchase-online/100>

### \*GOOD TO KNOW\*

- As of January 1, 2023, Croatia is the 20<sup>th</sup> member of the Eurozone, with the Euro as its official currency (with the **fixed conversion rate of HRK to EUR: €1= 7.53450 HRK**).
- Croatian is the official language, while English is widely spoken and understood.
- Free Wi-Fi is available in most hotels, restaurants, bars, and other public places.
- C and F-type outlets/plugs are used in Croatia.

- The standard voltage is 220 V, European style plugs. The usual frequency is 50 Hz.
- Most shops are open from 8.00 AM to 8.00 PM on weekdays and from 9.00 AM to 2.00 PM on Saturdays.
- Banks/post offices are generally open on weekdays from 8.00 AM - 7.00 PM, Saturdays until 2.00 PM.
- Major credit cards (MasterCard, Visa, and Diners) are also accepted at hotels, restaurants, and most shops.
- Smoking is not permitted inside any public buildings, including meeting venues, restaurants as well as hotels. Smokers are asked to smoke outside in the open-air area.
- Tipping is optional but always welcome.
- The tap water is safe to drink.
- In Croatian 'Thank you' is 'Hvala' and 'Please' is 'Molim'. Both words are magical. ☺

MAP 3: Summer Institute Location


MAP 4: Bus Instruction to Summer Institute Location

#### MAP 1: Bus station "Žabica" → Hotel Jadran

To reach Hotel Jadran, you can use Rijeka public transport – **bus line 1** (direction: Bivio → Pećine Plumbum).

→ starting bus stop: Žabica

→ bus stop: Jadran (the bus stops in front of the hotel)

**MAP 2: Bus station "Žabica" → Hotel Continental**

To reach Hotel Continental, you can use Rijeka public transport – **bus lines 1, 2, 6, 7, 7A.**


→ starting bus stop: Žabica

→ bus stop: Fiumara (the bus stops near the hotel)

After you get off the bus at Fiumara bus stop, proceed straight ahead to the traffic light (there should be a coffee shop "Štriga" in front of you when you cross the road). On your right, you will see a big white-yellow building – your hotel.


**MAP 3 LOCATION OF THE SUMMER INSTITUTE:**
